### **REGULATIONS:**

1. Each artist may enter 4 pieces of art. (Crafts and Sculptures **ARE NOT ACCEPTED**) Only original art will be accepted – oils/acrylic, watercolor or other media. No copies of copyrighted works (such as photo, magazines or ads), no painting worked on by an instructor or other person or art work shown previously at the Covenant Center Art Show, will be accepted. All art is to be suitable for family viewing. **ALL WORKS MUST BE FRAMED AND READY FOR HANGING.** If your work does not have a wire or saw tooth hanger or falls during the show due to inferior hardware on the picture, a \$2.00 fee will be charged. Watercolors must be under glass. Size of art must not exceed 36" in length or width (including frame).

FEES: Professional	\$4.00 per piece
Non-Professional	\$4.00 per piece
Student (grades 7 - 12)	\$2.00 per piece
Photography (Professional & Non-Professional)	\$4.00 per piece

2. Entries will be received at the exhibit site on Sunday, July 26<sup>th</sup> from 12:30 – 2:30 p.m.
3. Entries will be removed on Sunday, August 2<sup>nd</sup> between 5:00 – 6:00 p.m. **ABSOLUTELY NO WORK CAN BE REMOVED BEFORE THAT TIME, AND CANNOT BE REMOVED WITHOUT THE ASSISTANCE OF AN ART SHOW WORKER.**
4. Every precaution will be taken to protect the art work. However, the church cannot be responsible for damage or loss.
5. If there are not a sufficient number of entries in one category, no award will be given.
6. **ARTIST'S NAME, ADDRESS, PHONE NUMBER, TITLE OF WORK, CLASSIFICATION, MEDIUM and PRICE (if for sale) MUST BE ON THE BACK OF ALL ENTRIES.**
7. A 15% commission will be retained on all exhibited works sold.
8. Please see an Art Show worker before photographing any exhibited works.

### **CLASSIFICATIONS:**

1. **Professional:** Any artist with one or more years of college art training or its equivalent, or anyone who exhibits/sells his/her art/photography.
2. **Non-Professional:** Anyone who does not meet the above requirement.
3. **Student:** Any student who has completed seventh through twelfth grades.  
(June graduates may choose to elect the Non-Professional category.)

**JUDGING:** Winners will be announced by the local media.

**MONEY AWARDS:** Money Awards and Special Awards are listed on the Application Forms.
